June 8	<ul style="list-style-type: none"> ➤ TUITION PAYMENT DUE FOR SUMMER QUARTER REGISTRATION. Students who register after June 8, tuition payment is due by 4:30pm the next business day. ➤ Last day to enroll for Tuition Installment Payment Plan (TIPP) registration by 4:30pm
June 12 - 16	<ul style="list-style-type: none"> ➤ Stomping Grounds College Store Spring Quarter course materials buy-back
June 12	<ul style="list-style-type: none"> ➤ Admission application deadline for SUMMER Quarter (for new students with no prior college)
June 19 - 20	<ul style="list-style-type: none"> ➤ Faculty Workdays. No Classes.
July 3 (Monday)	<ul style="list-style-type: none"> ➤ SUMMER QUARTER CLASSES BEGIN!
July 4	<ul style="list-style-type: none"> ➤ Holiday – Independence Day. Campus Closed
July 5 	<ul style="list-style-type: none"> ➤ Last day to add classes online in ctcLink or in-person without instructors signature/permission ➤ Last day for students to be automatically moved to waitlisted classes (if space avail by noon)
July 6	<ul style="list-style-type: none"> ➤ Instructor signature required to add classes even if space is available ➤ Division dean AND instructor signatures required for full online classes ➤ CCS Employees, Washington State Public Employees and Senior Citizens tuition waivers (as space available). (No signatures required on July 6th)
July 10 (Monday) 	<ul style="list-style-type: none"> ➤ Last day to receive 100% refund for reducing credits or withdrawing from SUMMER Quarter
July 11 – continued	<ul style="list-style-type: none"> ➤ To ADD a class: Instructor AND Vice President of Instruction signature/permission required. ((Dynamic Dated or OEE (open entry/exit) enrollment classes may be added without instructor signature until the first day of class)) ➤ Division dean, instructor, AND Vice President of Instruction approval is required for full online classes
July 11 – 17 	<ul style="list-style-type: none"> ➤ 50% refund period for reducing credits or withdrawing from SUMMER Quarter ➤ NO TUITION REFUNDS AFTER JULY 17
July 17 (Monday) 	<ul style="list-style-type: none"> ➤ Financial Aid Census date ➤ Last day to drop classes to prevent “W” being posted on transcript
July 18 - July 31	<ul style="list-style-type: none"> ➤ Dropping classes will post “W” on transcript
July 31 	<ul style="list-style-type: none"> ➤ Last day to drop classes or make schedule changes from SUMMER Quarter ➤ Last day for “W” grade
August 10	<ul style="list-style-type: none"> ➤ SUMMER Quarter grade rosters available to instructors for grading
August 17	<ul style="list-style-type: none"> ➤ Last day of SUMMER Quarter classes
August 21	<ul style="list-style-type: none"> ➤ SUMMER Quarter grades must be submitted online by 8:00 p.m.
August 22	<ul style="list-style-type: none"> ➤ SUMMER Quarter grades available to students on ctcLink Student Center. View grades online at www.ctcLink.Spokane.edu
